

**CITY OF BELLEVUE**  
**ORDINANCE 2010-08-01**

**AN ORDINANCE AMENDING ORDINANCE 85-1-3 AND CHAPTER 112.20 OF THE BELLEVUE CODE OF ORDINANCES PERTAINING TO THE CLASSIFICATION OF ALCOHOLIC BEVERAGE LICENSES AND ANNUAL FEES BY ADDING A “MICROBREWERY LICENSE” AND “RESTAURANT WINE LICENSE” TO THE CLASSIFICATION OF LICENSES.**

**WHEREAS**, The Commonwealth of Kentucky has promulgated statutes pertaining to the issuance of a “microbrewery license” and “restaurant wine license” and has established regulations for same; and

**WHEREAS**, the City of Bellevue’s Alcoholic Beverages ordinance does not recognize the issuance of a “microbrewery license” nor a “restaurant wine license” within the city; and

**WHEREAS**, interest in the recognition and establishment of the classification of a “microbrewery license” and a “restaurant wine license” has been expressed to the city; and

**WHEREAS**, The Board of Counsel of the City of Bellevue has reviewed the request to establish the classification of a “microbrewery license” and a “restaurant wine license” and determined it would be beneficial to establish same.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Council of the City of Bellevue, Campbell County, Kentucky, as follows:

SECTION I

That Ordinance 85-1-3 and Chapter 112.20 of the Bellevue Code of Ordinances shall be amended as indicated below.

§ 112.20      **CLASSIFICATION OF LICENSES; FEE SCHEDULE.**

The following kinds of distilled spirits, wine, and malt beverage licensees may be issued by the city and the annual fees for each license shall be:

Distiller’s license, per annum	\$    500
Rectifier’s license, per annum	1,500
Blender’s license, per annum	1,500
Wholesaler’s license, per annum	600
Retail package license, per annum	500
Retail drink license, per annum	500
<u>Restaurant Wine License, per annum</u>	<u>400</u>

Special private club license, per annum	100
Special Sunday retail drink license, per annum	100
Nonresident, special agent, or solicitor's license, per annum	20

<b>(B)</b> <u>Malt Beverage Licenses</u>	<u>Fees</u>
Malt brewer's license, per annum	\$ 250.00
Malt distributors license, per annum	200.00
Malt retailer's license	
New, per annum	200.00
Renewal, per annum	150.00
<u>Micro Brewery, per annum</u>	<u>250.00</u>

<b>(C)</b> <u>Temporary and Other</u>	<u>Fees</u>
Special temporary spirit and wine retail license, per month or part of a month	166.66
Special temporary malt retail license, per month or part of a month	25.00
Transfer of license	20.00
