ORDINANCE 2019-01-01

AN ORDINANCE AMENDING BELLEVUE CODE OF ORDINANCES SEC. 112 ESTABLISHING A ONE-TIME EXCEPTION TO CHAPTER 112 OF THE BELLEVUE CODE OF ORDINANCES TO ALLOW MALT BEVERAGES BY THE DRINK OR BY THE PACKAGE AND DISTILLED SPIRITS AND WINE BY THE DRINK OR BY THE PACKAGE TO BE SOLD BEGINNING AT 9:00 A.M. ON SUNDAY, MARCH 17, 2019.

WHEREAS, Kentucky alcoholic beverage control laws allow regulation of Sunday sales by local governments; and

WHEREAS, Chapter 112 of the Bellevue Code of Ordinances allows the sale of: (i) malt beverages by the drink or package on Sundays from the hours of 11:00 a.m. Sunday until 2:00 a.m. Monday, (ii) wine and distilled spirits by the package from 11:00 a.m. Sunday until 2:00 a.m. Monday, and (iii) wine and distilled spirits by the drink from 11:00 a.m. Sunday until 2:00 a.m. Monday, if a special permit is obtained; and

WHEREAS, Saint Patrick's Day will be celebrated on Sunday March 17; and

WHEREAS, several proprietors of local businesses have requested permission to serve alcoholic beverages earlier than 11:00 a.m. to commemorate this event; and

WHEREAS, in support of local business, the City of Bellevue desires to provide a one-time exception to § 112.40 of the Bellevue Code of Ordinances to allow the sale of malt beverages by the drink or package and distilled spirits and wine by the drink or package between the hours of 9:00 a.m. and 11:00 a.m. on Sunday, March 17, 2019 by businesses who are authorized to sell alcoholic beverages by local regulations.

NOW THEREFORE,
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLEVUE,
CAMPBELL COUNTY, KENTUCKY:

Section 1

March 17, 2019 Exception. Notwithstanding § 111.40 of the Bellevue Code of Ordinances, licensees may sell malt beverages by the drink or by the package and distilled spirits and wine by the drink or package between the hours of 9:00 a.m. and 11:00 a.m. on Sunday, March 17, 2019.

Section 2

This ordinance shall take effect and be in full force when passed and recorded according to law.
