

**CITY OF BELLEVUE**  
**ORDINANCE 2019-07-01**

**AN ORDINANCE AMENDING AND INCREASING THE PENALTIES FOR PARKING REGULATION VIOLATION CITATIONS IN THE CITY OF BELLEVUE, AND REPEALING A PROVISION OF THE ORDINANCE REGULATING THE DISPLAY OF VEHICLES FOR SALE.**

**WHEREAS**, City staff reviewed the present penalties for traffic and parking violation citations in the City of Bellevue and determined they need upgraded and increased; and

**WHEREAS**, the Police Department and Code Enforcement staff recommend the purchase and installation of parking and code enforcement software in an effort to increase efficiencies in processing parking and code enforcement citations, and the increase in fees will assist the City in paying for the new programming; and

**WHEREAS**, the present fine structure has not been modified for many years; and

**WHEREAS**, increasing the penalties will increase the likelihood of compliance for the infractions violated; and

**WHEREAS**, a provision in Chapter 72, Bellevue Code of Ordinances Sec. 72.10 is more than likely unconstitutional as it regulates signage on a vehicle displayed for sale on any street.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNCIL OF THE CITY OF BELLEVUE, KENTUCKY:**

Section 1

That Bellevue Code of Ordinances § 72.99 is hereby amended as follows:

**§ 72.99 PENALTY.**

(A) Any person violating Bellevue City Code §§ [72.03](#)(A)(10), [72.03](#)(A)(11) ~~and or~~ [72.11](#) shall pay a fine of ~~\$50.00~~ \$100.00.

(B) Any person violating Bellevue City Code [72.68](#) shall pay a fine of ~~\$50.00~~ \$100.00.

(C) Any person violating any other section of Chapter 72 shall pay a fine of ~~\$10.00~~ \$25.00.

(D) Any person receiving a citation for any parking violation in the city may pay the parking fine at the office of the City Clerk/Treasurer within seven (7) days. If the fine is not paid within seven (7) days, the fine will double in amount. If the fine is not paid within thirty (30) days of issuance of the citation, the fine will triple in amount.

(E) Any person receiving a ticket for violating § [72.12](#) shall pay a fine of ~~\$10.00~~ \$50.00 at the office of the City Clerk/Treasurer within seven (7) days of the time issued. If the fine is not paid within seven (7) days, the fine will double in amount. If not paid within thirty (30) days, the amount of the fine will triple.

Section 2

That Bellevue Code of Ordinances § 72.10 is hereby amended as follows:

§ 72.10 ~~DISPLAY OF PARKED VEHICLE FOR SALE~~ RESERVED

~~It shall be unlawful to park a motor vehicle displayed for sale or a motor vehicle on which demonstrations are being made on any street.~~

Section 3

Any ordinances or parts thereof in conflict herewith are to the extent of such conflict, hereby repealed.

Section 4

That this ordinance shall take effect and be in full force when passed, published and recorded according to law.
