**AN ORDER APPROVING THE CITY OF BELLEVUE GOLF CART
RULES AND RESTRICTIONS.**

WHEREAS, The City of Bellevue has authorized the use of golf carts within the City's jurisdiction per an ordinance; and

WHEREAS, the ordinance provides that rules related to the use of golf carts are to be created by the City Administrator with approval of the Board of Council; and

WHEREAS, the attached rules and restrictions are to be implemented for the safety of the City's residents and visitors.

NOW, THEREFORE, BE IT ORDERED, that:

The rules and restrictions for the use of golf carts in the City of Bellevue are attached and incorporated by reference, and are hereby approved.

CITY OF BELLEVUE GOLF CART RULES AND RESTRICTIONS

1. Restricted Roads.

Golf carts may not be operated on the following roadways:

- a. Memorial Parkway.
- b. On any portion of Fairfield Avenue other than to cross Fairfield where a traffic light is located. The use of golf carts on Fairfield Avenue will be allowed during parades and special events approved by the City. The use of a City golf cart for watering plants is allowed on the sidewalks on Fairfield Avenue.

2. Inspection and license.

- a. The golf cart must pass an inspection by the Campbell County Sheriff.
- b. A Golf Cart Application must be completed and submitted to the City.
- c. The driver must be licensed to drive.
- d. A \$25 sticker must be paid for a Bellevue registration sticker.
- e. The registration sticker must be displayed on the golf cart windshield.
- f. The registration sticker is valid from May 1 to April 30 of each year. There will not be a pro-ration of the fee.
- g. Proof of insurance must be with the golf cart at all times.

3. Required Golf Cart Equipment.

- a. Headlamps.
- b. Tail lamps.
- c. Stop lamps.
- d. Front and rear turn signals.
- e. One (1) red reflex reflector on each side as far to the rear as practicable, and one (1) red reflex reflector on the rear.

- f. An exterior mirror mounted on the driver's side of the golf cart and either an exterior mirror mounted on the passenger's side of the golf cart or an interior mirror.
 - g. A parking brake.
 - h. For each seat, a seatbelt assembly that conforms to the federal motor vehicle safety standard provided in 49 C.F.R sec 571.209 and as amended.
 - i. A horn that meets the requirements of KRS 189.080 and as amended.
 - j. A slow-moving vehicles emblem in compliance with KRS 189.820 and as amended.
 - k. A golf cart registration sticker from the City.
 - l. Proof of insurance.
4. Operator Requirements.
- a. Must have a valid operator's license.
 - b. Must have proof of insurance.
5. Golf Cart Rules.
- a. Golf carts shall not exceed a speed of twenty-five (25) miles per hour.
 - b. The head and tail lights must be illuminated during operation.
 - c. The golf cart does not hold more than six (6) people.
 - d. Golf cart shall only park on hard surface pavement in parking spaces and in parking spaces designated by the City in its parks.
 - e. The golf cart must comply with the Noise Ordinance of the City of Bellevue.
 - f. The driver of a golf cart must drive in the right hand lane unless making a left hand turn. If the golf cart is slowing the normal flow of traffic, the golf cart driver must yield to vehicles, where possible.
