ORDINANCE NO. 2021-02-01

AN ORDINANCE AMENDING ORDINANCE NO. 2019-11-05 CODIFIED IN SEC. 72.56 et seq. IN THE BELLEVUE CODE OF ORDINANCES RELATING TO PARKING CITATIONS CHANGING REQUESTS FOR HEARINGS FOR PARKING CITATION REVIEWS FROM THE BELLEVUE CODE ENFORCEMENT BOARD TO A ONE-MEMBER HEARING BOARD.

WHEREAS, Sec. 72.56 of the Bellevue Code of Ordinances states that the Bellevue Code Enforcement Board conduct hearings related to parking citation grievances; and

WHEREAS, the Board of Council desires that a Hearing Board consisting of one member shall have the responsibility and power to conduct hearings relative to grievances concerning the issue of parking citations.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF BELLEVUE, IN CAMPBELL COUNTY, KENTUCKY, AS FOLLOWS:

Section 1 – Parking Citation Hearings

Ordinance No. 87-1-1 is hereby amended as follows:

§ 72.55 ADOPTION OF STATE LAW.

The City hereby adopts the provisions of KRS 82.600 through KRS 82.640, which apply to the enforcement of parking ordinances within the city.

§ 72.56 HEARING OFFICER; HEARING BOARD.

(A) There is hereby established a Hearing Board as described in division (B) below, which ~~The City of Bellevue Code Enforcement Board~~ shall have the responsibility and power to conduct hearings relative to grievances concerning the issuance of parking citations.

(B) The Hearing Board shall consist of one (1) member to be known as the Hearing Officer. The term of office for the Hearing Officer shall be the same as the Mayor. The Hearing Officer is appointed by the Mayor and approved by City Council. ~~The Hearing Officer Code Enforcement Board~~ may conduct a hearing and shall have the authority to decide any grievance or appeal brought about by the issuance of parking citations.

§ 72.57 APPEALS.

The decision of the Hearing Board shall be final, and appeal from its action may be taken as described in KRS **82.600** through KRS 82.640.

Section 2.0 – Conflicting Ordinances Repealed

All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

Section 3.0 – Effective Date

This Ordinance shall be effective as soon as possible according to law.

The Ordinance shall be effective when read, passed and advertised according to law.
