Mayor Cleves reported on the following:

Zoom meeting with Governor Beshear today advised that first round of COVID-19 vaccines received will go to nursing home staff and residents, one-third for medical care professionals at hospitals and medical facilities. Next shipment will go to the above as well but will also include teachers.

Mayor distributed eighteen food and beverage applications to Bellevue business who qualify for the State program. These funds are on a first come first serve basis. Seventeen of the eighteen businesses applied on the first day. Big thanks to Melissa Morandi for her marketing efforts of the program and

Steve Brun from SB Comp for offering to provide assistance to anyone in need of help filing.

Shop Local weekend was a success in spite of the pandemic thanks to Melissa Morandi for her marketing efforts.

BNA each year has to prepare the garland and wreaths that adorn the City during the holidays. This year's volunteer event was held at Joe's Crab Shack. Special thanks to Kathy Barrett for organizing this annual event.

Solar panel stop signs at Taylor and Center have been successful and the City Engineer has advised that the stop light can now come down. The City is committed to pedestrian safety and has added more of the solar stop signs at Taylor and Division as well as Grandview and Foote. Both these areas are in a school zone.

Melissa Morandi, Communications Specialist will be hosting a virtual food drive which is normally done in person during the Holiday events on Fairfield. Donations can be dropped off at the City Building, with checks payable to the Bellevue Education Foundation. All monies raised will support both the St. Bernard Food Pantry and the Bellevue Food Pantry.

Police Chief Estepp reported on the following:

Department received a letter from Ft. Thomas Police Chief Casey Kilgore commending Officer Bonar for his assistance in a pursuit.

Officer Brown delivered holiday boxes of food to Bellevue families in need of a little extra help this Thanksgiving. Donated money was used to buy the food from Kroger. Department will partner with the Bellevue Dayton Fire Department for the Christmas Holiday drive.

Traffic enforcement on Fairfield will be ongoing as this is a very busy road.

Mayor Cleves requested City Attorney Dave Fessler who also serves as President of the Bellevue Education Foundation to present Resolution 2020-12-01 commemorating Ken Weber and creating a day in his honor to celebrate his services and irrefutable kindness to the students of Grandview Elementary. Mr. Weber since March of 2011 has donated \$101,332.00 to the Education Foundation. This program known as the PILOT program is focused on exposing students to cutting edge technology in the classroom by putting iPads in the student's hands and new technology at their fingertips. With Mr. Weber's efforts, every student at Grandview now has an iPad.

FOR THE RECORD:

Administrator Warnock further reported:

Fire Chief Adkins report provided to Council. Details include 190 calls for service in November, one firefighter still out due to COVID, 6 have contracted COVID. Mark Tumler, last of the volunteer Firefighters has retired. Mark served Bellevue and Dayton for sixteen years.

Code Enforcement Officer, Tom McDaniel report included that ten NOV were issued in November and four Citations issued. Attorney filed liens this week totaling \$10,000. Member Salzman noted that NOV and Citations appear to be down and asked if this is due to compliance or COVID – both.

Public Services continue with routine work and leaf pickup. Sidewalk preparation will be done for fourteen new trees which will be planted soon.

City Engineer report included, light at Center and Taylor can now be removed. FEMA project is still a work in progress. Lincoln Road will continue for three more weeks then will be on hold until spring for final blacktop coat.

Residents of S. Ward inquired about the utility poles being moved, this was due to the road slippage and Geotechnical work that needs to be done for stabilization.

Comp plan continues to be a work in progress.

Contactless drop box located in rear foyer of City building. Payments and donation checks for food drive accepted.

City Attorney, Dave Fessler read Ordinance 2020-11-01 updating the Official Zoning Map to include a residential cluster development overlay zone (RCD) to be overlaid on the existing residential -1A (R-1A) zone for a redevelopment of 724 Covert Run Pike for a second reading.

FOR THE RECORD:

City Attorney Dave Fessler read Order 2020-12-05 approving a payment in lieu of taxes agreement to provide funding for the development of the Shady Terrace Mobile Home Park into a single family home ownership residential site and authorizing the Mayor to execute the agreement on behalf of the City of Bellevue.

FOR THE RECORD:

City Administrator Frank Warnock provided Council with a detailed brief and broad summary of the Shady Terrace Mobile Home park site development. Available for questions on the development project included contracted City Attorney Donnie Warner, Attorney representing the developer Jim Parsons, representing the developer was Charlie Pond, Jeff Chamot and Doug Moormann.

Member Guidugli noted the current annual tax revenue from the Shady Trailer Mobile Home Park of \$1,158.78 and encouraged Council to support this \$32,000,000. residential development.

Member Fisher requested a detailed explanation on the financial aspects of the PILOT payments as well as assurance that if an economic downturn happens the City has no responsibility. Representatives of the development sited current examples of other local

cities that have issued Industrial Revenue Bonds, a brief synopsis of payment to the city projections and assurance that the Developer takes all risks, the City is not "on the hook".

MOTION By Guidugli seconded by Salzman that Order 2020-12-05 be adopted as read.

City Attorney Dave Fessler read Order 2020-12-06 approval of a Memorandum of Agreement between the City and Neyer Properties relating to the acquisition, construction, equipping and installation of a residential project to be located within a downtown business district as designated by the City; agreeing to undertake the issuance of Industrial Building Revenue Bonds at the appropriate time to pay the costs of acquiring, construction, equipping and installing said project and facilities; and taking other preliminary action.

Member Hogan questioned why "Downtown Business District" is referenced in the development area. Attorney Jim Parsons provided explanation of the qualifications for the use of Industrial Revenue Bonds.

MOTION By Salzman seconded by Kruse that Order 2020-12-06 be adopted as read. Motion carried.
