

COUNCIL CHAMBER CITY OF BELLEVUE, CAMPBELL COUNTY, KENTUCKY

MINUTES OF THE REGULAR MEETING OF COUNCIL AUGUST 14, 2024

Board of Council met in regular session on the above date at 7:00 p.m. Mayor Charlie Cleves called the meeting to order. The following answered roll call:

MOTION: By Salzman seconded by Guidugli to excuse Councilmember Pat Hogan. Motion carried.

MOTION: By Almoslechner seconded by Fisher that the Minutes of Regular Council on July 10, 2024 are accepted as received. Motion carried.

FOR THE RECORD: City Attorney Dave Fessler read a correspondence from Michael Knight thanking the City of Bellevue during his tenure with the city. Officer Knight resigned from the Bellevue Police Department August 1, 2024.

Assistant to the City Administrator Pierce Turner reported on the following:

Nearing completion of Brun Park. The shelter arrived today and will be installed in the coming days.

Ordered new playground equipment for Swope Park.

Beach Park will be the next park to update. Councilmember Fisher stated we should create a master plan, 10 years of funding, grand vision for the park.

The city has received a grant for O'Fallon Park.

Reminded the community of Reach Alert. Great communication tool.

Councilmember Salzman thanked Pierce for his work on the parks; you can really see the vision. Councilmember Guidugli thanked the mayor for all his hard work as well.

MOTION:

By Guidugli seconded by Fisher that Ordinance § 2024-07-01 an ordinance amending the City of Bellevue zoning ordinance, subdivision regulations, and historic preservation

ordinance related to civil penalties. VOTE: Yes 5 No 0. Motion carried. THE ORDINANCE BECAME LAW.

MOTION: By Almoslechner seconded by Kruse that Order 2024-08-01 an order authorizing the mayor to enter into an interlocal agreement with the City of Dayton to allow visitors with alcoholic beverages in approved cups in the cities of Bellevue and Dayton entertainment districts to freely enter and depart each respective district be adopted as read. Motion carried.

MOTION: By Fisher seconded by Salzman that Order 2024-08-02 an order authorizing the mayor to enter into a revocable license agreement with Wilmar Arturo Franco to allow Mr. Franco to place a deck on City public way property be adopted as read. Motion carried.

MOTION: By Almoslechner seconded by Guidugli that Order 2024-08-03 an order accepting Bachman Auto Group's bid as the lowest and most responsible for the purchase of two 2024 Chevy Tahoe's be adopted as read. Motion carried.

MOTION: By Salzman seconded by Fisher that Order 2024-08-04 an order approving an agreement with Professional Lawn Care, Inc., for mowing services be adopted as read. Motion carried.

MOTION: By Guidugli seconded by Almoslechner that Order 2024-08-05 an order finding and declaring City of Bellevue equipment as surplus property and authorizing its disposition is adopted as read. Motion carried.

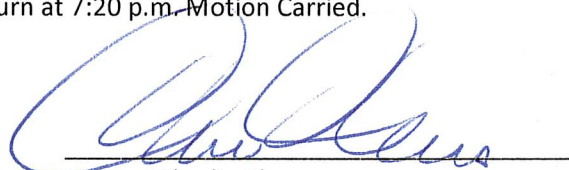
FOR THE RECORD:
