By Salzman seconded by Kruse that Order 2024-09-04 an order authorizing the mayor to execute and deliver a third amendment to disposition and development agreement providing for the extension of the deadline for which Neyer Properties, Inc. must satisfy the inducement order conditions as defined in the disposition and development agreement dated August 11, 2022, as amended; and agreeing to take such other action as necessary or required in furtherance of the third amendment.
