ORDINANCE NO. 2025-10-01

**AN ORDINANCE AMENDING ORDINANCE 2003-11-01, AS CODIFIED
IN SECTION 50.10 OF THE BELLEVUE CODE OF ORDINANCES,
REGARDING THE USE, RESTRICTIONS, RULES AND COSTS FOR THE
USE OF THE SOLID WASTE TRANSFER STATIONS FACILITY.**

WHEREAS, the Board of Council adopted Ordinance 2003-11-01, as codified in Section 50.10 of the Bellevue Code of Ordinances establishing rules, restrictions and costs for the use of the solid waste transfer station for the dumping of solid waste; and

WHEREAS, the Board of council wishes to amend said ordinance to better define the use and restrictions of the solid waste transfer station, and to amend the cost for the use of the solid waste transfer station.

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY OF BELLEVUE, CAMPBELL COUNTY, KENTUCKY, that Ordinance 2003-11-01 as codified in Section 50.10 of the Code of Ordinances be amended as follows:

§50.10 CITY TRANSFER STATION FACILITY

(A) Residents and businesses, property owners occasional users. Persons who reside in a dwelling in Bellevue or who own residential property in Bellevue, and businesses located in Bellevue who utilize the transfer station less than six (6) times per calendar year may use the transfer station facility upon first obtaining a permit from the City Clerk and paying a flat rate of twenty-five dollars (\$25.00) seventy-five dollars (\$75.00) for each pick-up truck or trailer load not exceeding 2 1/2 cubic yards, or fifty dollars (\$50.00) one hundred and twenty-five dollars (\$125.00) for other trucks or trailers exceeding 2 1/2 cubic yards but less than six (6) cubic yards provided that they show current documentation which demonstrates residency or property ownership within the city.

(B) Businesses, occasional users. Businesses located in Bellevue who utilize the transfer station less than six (6) times per calendar year or out of city businesses may use the transfer station facility upon first obtaining a permit from the City Clerk and paying a minimum rate of twenty-five dollars (\$25.00) one hundred dollars (\$100.00) for each pick-up truck or trailer load not exceeding 2 1/2 cubic yards, or fifty dollars (\$50.00) per load exceeding 2 1/2 cubic yards but less than six (6) cubic yards. Out of city businesses must be licensed in the city and can only deposit waste generated from business done in the city.

(C) Residents, property owners and businesses, regular users. Persons who live in, own property in or operate businesses in the city who utilize the transfer station more than six (6)

~~times per calendar year shall be classified as regular users. Regular users shall pay a minimum rate of fifty dollars (\$50.00) per 2 1/2 cubic yards or portion thereof.~~

That this Ordinance shall be in effect, when read, passed, and published according to law.
